The primary bedroom has a king sized bed and a private entrance directly out to the large 20'x55' lanai, two walk-in custom closets and a large private bathroom suite separate from the rest of the house. The other two bedrooms are located on the opposite half of the house with a full bathroom between the two (queen) bedrooms. There is a pocket door at the hall entrance, enhancing the privacy of these spaces. The divider wall between the great room and the lanai is a stacking glass door system that opens the inside of the house to the outside spaces (fully furnished screened lanai, Weber gas grill, outdoor television, heated pool with an attached hot tub, towels, pool floats and noodles, too. The house is appointed with an electric fireplace, large assortment of books, games, puzzles and Smart TV's to keep all that enter feeling right at home. Off of the Great room is a dining room, foyer and den. Large scale tile floors throughout, except the bedrooms and den have Teak wood flooring. Literally every space in the house is fully stocked with everything one would need. Just bring your clothes and enjoy the Florida sunshine!

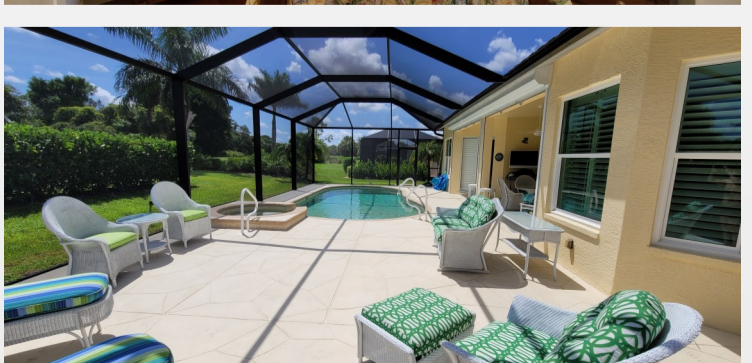
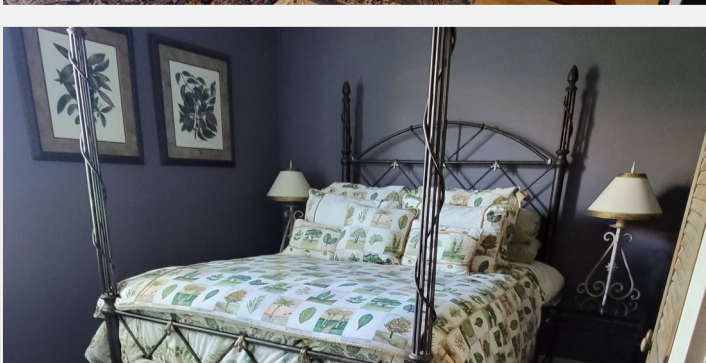
